VCTC's mission is to improved mobility within the County and increase funding to meet transportation needs. To fulfill that mission, the VCTC establishes transportation policies and priorities ensuring an equitable allocation of federal, state and local funds for highway, transit, rail, aviation, bicycle and other transportation projects.

**VCTC meets the first Friday of every month (except August) at 9:00 am at Camarillo City Hall Council Chamber. Members are asked to make themselves available until noon on meeting days, though most meetings adjourn at approximately 10:30 am. Compensation for meeting attendance or representing VCTC at a meeting is \$100 per meeting, with a 2 meeting maximum in one calendar month.**
