POLITICAL SIGNS: May be displayed 3 months prior to Municipal Election.	August 10, 2016
CAMPAIGN FILINGS - Within 24 Hours Contribution Reports (Form 497) Report any contribution or independent expenditure activity in the amount of \$1,000 or more for the period covering August 10, 2016 through November 8, 2016. This form must be filed by fax, guaranteed overnight delivery service, or personal delivery.	August 10, 2016 – November 8, 2016 File within 24 hours. Reports due on a weekend or state holiday, other than the weekend before an election, are extended to the next business day.
NOMINATION PERIOD (Extension): If upon the close of the nomination period, an eligible incumbent has not filed, the nomination period for that office will be extended for 5 days for candidates other than the eligible incumbent.	August 13, 2016 through August 17, 2016
